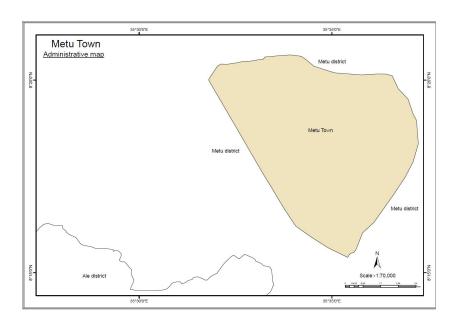

Introduction

The crucial issue in urban development policy and strategy is that cities that have gained legal status will be promoted based on their profile and basic data as they show growth and change, in the enforcement decree of the Oromia regional state cities guidelines No.2/2010, regulation No. 186/2008 are clearly stated. Accordingly, while Mattu became the capital of Ilu Aba Bor zone, the town was established in 1905, but in 1940 it started to be governed by the Planning House, and in 1959 the First Master Plan was prepared for it being that the town boundary was 800 Hectares at that time.

On the other hand, the town entered in to reforms under the ordinance No. 65/1995 issued by the state government of Oromia region to determine the urban reforms and our town has been structured as a 2nd level (town B) since 1996 to be ruled under the mayor. In addition by regulation No.186/2008 the town of Mettu is structured as a middle level town. However, according to the urban promotion guidelines, a town has a basis for promotion within four years even if it meets the requirements for promotion 1996 and since it entered the central urban structure and has duration of 7 years, it has not developed from the current development level to the high level town. However, Mettu is currently one of the fastest growing towns in the South West of the country.

1.2. HISTORY OF THE WESTERN OROMO TRIBES

1.2.1. THE ARRIVAL OF THE OROMO TRIBES TO METTU TOWN

History tells us that the foundation of human origin is in the East Africa continent. Archeological studies of remains of human skeletal that is older than four million years found in East Africa, Ethiopia. The race of human ancestry that lived in the region of Ethiopia was Cush, Sem, Omo and Abbayya. While the Tulema Oromo expanded their territory Northwards through central Oromia, the Macha Oromo enacted their laws at Odaa Nabe and expanded their territory to the Western Oromia. Macha has five doors. They are called Liban, Obo, Guduru, Calliya and Limmu. Oboo, one of these five Mechaa children, had three children. They are known as Sayyo, Leqa and Tumme. These Oboo doors later became more numerous and expanded their land territory and came to occupy the place called Ulmayya desert. The Ulmayya desert they occupied is said to be the source of the Dabana river in the Arjo, Baddeelle and North Nole areas. Thus, while Leka took the middle, Seyyo went down to the west, and Tumme went to the left and took what is now called Ilu. They then continued to expand their land by "Daggal Saqi".

"Daggal Saaqi" means when they went a long way for hunting and when they saw suitable land for agriculture they took it and settle their relatives and tribe.

Therefore, the Mecha Oromo tribe expanded its land to Ilu and occupied this suitable land and settled others. Some evidence explains that the Oromo tribe came here and occupied the land and is still living on it.

Metu has been an important market of the Coffee trade with several foreigners residing in the as early as the 1930s to buy the crops from local farmers. At this early date the town was connected by telephone to Gore and Addis Ababa. The town's source of electri town is the nearby Sor Hydroelectric station. The town also has a high school and hospital timely.

Metu is known for its local Waterfalls, the best known being the Sor waterfalls and their surrounding forest with its wild life. And the Sor river has the wide history it is the first river from Illu Aba bor zone Electric power generate, that serve as irrigation, fish raring support as recreational purpose and also it is known by celebrating site of Oromo culture herrecha heritage so the River that ancient history's and it has length 13 km

1.2.2. ESTABLISHMENT AND NAME OF THE TOWN OF METTU

Tumme, who made the door/children/Obo and moved over to this side of the three, occupied what is now called Ilu, has four children. They are; - Nonno, Sibbo \Sibu, Dapho, and Bunno. It can be seen from the list above that Nonno is one of these four sons of Tumme, who had five wives; namely;- Mother of Hurrumu, Mother of Bilo, Mother of Adalle, Mother of Halelu, and Mother of Abbayi. Among these women, Hurrumu's mother and Halelu's mother were both pregnant. Abbayyi's mother, however, was not immediately understood to be exactly pregnant except that she might become pregnant too. This Nono was fighting on horseback at that time. Among his wives Halelu's mother age is older than the others and

when he goes to her he says, "It would have been gossip, don't forget", he told the Halelu's mothe about the mother of Abbayyi. While he was saying this, the gossip of doubt came true and the pregnancy grew and the mother of Abbayi gave birth. Then when she gave birth they named the child she gave birth to 'Mattu' meaning related to the 'gossip'. The elders and historians say that the mother of Halelu was named 'Haleeluu' because they were pregnant together. 'Ni haleelte' meaning hit the target. "Mattu" is one of 'Nonno's children who came from the door of Mecha Oromo, according to the story. History tells us that the present area was named after a man called "Mattu" who was one of the doors of Noonnoo. When the town of Mattu founded the area called from the name of this man. The town of Mattu was founded in 1905 by a man named Dajjash Gename. The houses were built from grasses in the Taba "Damoosoo" area near the present Abdii Bori during the rule of King Minilik. Dajaash Ganame, was then appointed by Minilik as the governor of Iluu Abbaa Boor as "Xaqilai Gizati". Therefore, the town of Mettu was established in the Minilik administration system.

On 9 July 1927, the Greek national T.Zewos and A.Donalis were awarded a contract to link the town Gore by road with Gambella, distance of 180 kilometers. In the 1930s, Mettu was the last stop before reaching Gore. At the time it was a center for mule caravans and later also as a terminal for the Ethiopian transport motor company.

The private weekly Urji reported 11 July 1995 that some 400 prisoners reportedly escaped when a grenade was set off at the Bishari prison in Mettu. The prison guards were killed immediately as well as at least six other people

1.2.3. Demographics

The 2009 national census reported a total population for Mettu of 28,782, of whom 14,400 were men and 14382 were women. The majority of the habitants practiced Muslim, with 47.55% of the population reporting they observed this belief, while 26% of the population said they were Ethiopians Orthodox, and 26% are protestant.

1.2. 2.4 Climate Condition of the Town

The Climate data for Mettu Town is 1971-2000. The pioneer name of Mettu town was coined the Biblical name 'Nazareth' by Emperor Hailesillase who was labeled as the titular head of the church on his tour to the town. After the fall of the defunct want on regime rode to power on the horse back of the 1974 revolution in 1991, the town officially reverted to its original Oromo name, Mettu in 1992.

As the years progressed, the town has become the hot spot of tourism, conference and investment and dependable Oromia. In recent years, the evidences presented above depict an iconic town of Mettu with good peace in reputes and an immense potential for growth and development in the country has shown significant growth in physical area, population and economic aspects over the past century. Currently, it is a noted epicenter for Mettu University and other colleges, reliable transportation, mosques, churches, luxury hotels, restaurants, hoteliers, leisure facilities, tour operators, shops, recreational sites, public gatherings place in the country. These were made the town an astonishing place to visit, relax and spend a good time both domestic and foreign visitors and created a hotbed for its flourish in time, albeit there is lack of tranquil and amusing breath taking sites to tourists and recreation seekers from the town and afar. To recapitulate, the town is demonstrating fast development in various spectrums of town development at this specific time vise-a-vise the preceding times amidst the challenges of rudimentary and dysfunctional service delivery system and the proliferations of squatter settlements on the brinks of the town are tarnishing the image of the town in various ways.

2.1 Physical Background of Mettu town

In the before section, efforts were made to introduce the back ground of the town in the first place explicitly. This chapter gives emphasis to the physical elements of environment that play detrimental role either in facilitating or inhibiting human inhabitation of any area of the world of which Mettu town is no exception.

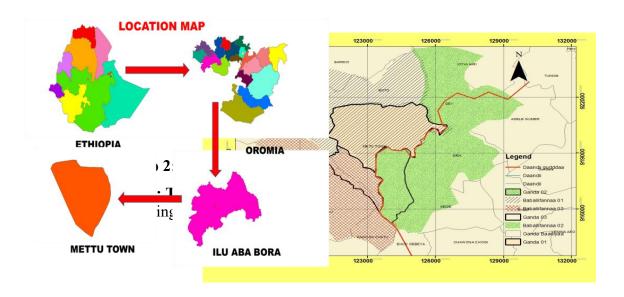
2.1.2 Location

Mettu Town is one of the urban centers in the Oromia regional state located in Illubabor Zone 600 KMs from Addis abeba to the south western part of Ethiopia across the main rod reach the Gambella region. As far as vicinal location is concerned, it is located near to Gumero tea development project minimum distance of 36 kilometers the south west of Yayo coffee forest plantation and Sor water fall River and South West of Addis Ababa which is now serving as a blood vein of the people of Illubabor Zone and Mettu Town at a close proximity and distance of 600 kilometers via express road that leads from Addis Ababa to the, Mettu town stretches from 80 3311 to 80 3611 North latitude and 390 111 5711- 390 211 1511 longitude

2.1.3 Topography/Relief of the town

Relief is basically the terrain of the earth. It shows the difference in elevation of various physical geographical features in given area that means around our town such as mountains, valleys, pilins and plateaus all have different elevations. Then the area that is taken in to consideration as mountain is Kollo

Korma and that area is very beauty full event and the area taken as low land is around Sor River from the town and all area are very attractive features and they give for the town smart background.

Mettu town is a market town and separate woreda of in South Western Ethiopia, Located in the Illu Abbabor zone of the Oromia along the Sor River. The Sor river is we can take it as the blood vein or the heart of the town because of its favor.

Mettu town which is serving as the administrative, commercial, manufacturing and educational hub in the region also lies at the average elevation of 1,745 meters. The undulated topography on all margins of the town makes the town more susceptible to awful flood inflicting devastation on the life of the people and hard owned property and infrastructure in the town, when heavy rainfall occurs.

2.1.4 Drainage

The drainage of Mettu runs from North to South due to the pattern of town's surface configuration. As the result of the absence of perennial river and stream that provide people with water for drinking, bathing, generating electric town and irrigation schemes in the master catchment of Mettu town, different gullies those almost remain dry for many months of the year cross the town and drain into the Sor River and Medde river then pass to the Gebba river during the rainy season.

During heavy rainfall, many deep gullies get flooded in Mettu town and destroy the some peoples house and it is eroded in to the dich and splitting in to the village due to the amalgamations of different factors like lower storage and more runoff, the profile of the town, less filtrations of water in the impervious part of the town that paved by either cobblestones or asphalt.

To reduce these gullies the Mettu town administration and the town project committee were taken many different actions like dich and urban greenery.

2.1.5 Soil Characteristics

For urban world the soil has value than gold and is the underlined foundation of all of the buildings and others. The residents of the town are dependent on the soil for building house, factories, vegetable garden, seedbed of flowers, etc.

The soil condition and class of the soil of the town is soft soil and red soil as well as filled with black rock. When we look at the geographical situation of Mettu town, 53 % is flat land, 37% is hilly, 7% is caffee (river), and 3 % is other.

2.1.5. Climatic Conditions

The temperature of the town has an average temperature of 25-32°C (degrees Celsius). The annual average rainfall of the town is 250-2500mm. The typical weather in the town of Mettu is a highland. The climate is warm, moderate and occasionally cold. The soil condition and class of the soil of the town is soft soil and red soil as well as filled with black rock. When we look at the geographical situation of Mettu town, 53 % is flat land, 37% is hilly, 7% is caffee (river), and 3 % is other.

The area climate is very crucial for the life of human beings, the life of animals/animals. Accordingly, the climate of Mettu town is suitable for the life of human beings, animals/various living things. Mettu Town is located at an altitude of 1460 Meters to 1740 Meters above sea level and has a temperate climate of 25-32°c degrees Celsius

The temperature humidity of is refers to the amount of moisture in hair compared to what the air can all that temperature.

2.5.1 Rainfall

Our town gains rain throughout a year and is ever green, conducive to live, and is suitable for summer and winter agriculture; that makes it is crucial for economic growth and investment.

Mettu Town has altitude range of 1200 to 1800 meter above sea level. The town also mean annual temperature of 30°c. The weather condition of the woreda is 'Woyinadega' (mid altitude), (WoARD2012). The rain fall of the Mettu town is from April to the beginning of the December. The ranging of the rain fall is maximum of 3000 mm to the minimum of the 2200 mm

2.5.3 Wind

Wind that picks up the finer and more fertile sand and silt particles and moves them away miles as dust is a moving air that heralding the rain and transporting the clouds to various places. Mettu is windy and fortune for its fast fresh air circulations in the region.

Being it is one of the sunniest and peasant windiest cities in the Green event of Town, Mettu experiences intense and perpetual high wind speed that mostly blow from east to west. This moderates the debilitating effects of high temperatures in Mettu Town.

Escaping dust was difficult in Mettu and the residents were sprinkled with harmless dust, before its major roads paved by asphalt or cobblestone. Dry winds that pass over Mettu between October and December sometimes lash the town and sway trees 'boughs. The presence of this very strong speed of wind paved

way for the installation of wind turbines, alternative green energy sources on the skirt of the town at 5 kilometers distance from the center of the town.

2.6 Natural Vegetation

It is not hard to imagine that natural vegetation is the reflection of the prevailing climatic condition of any area. As far as natural vegetation cover is concerned, the locality was blessed with precious natural vegetation of desert type that withstands desert climatic condition and adjust their life cycle to the prevailing climatic conditions, before the natural vegetation used for food, extraction of medicine and ecological balance has been almost destroyed as the result of intense man-made duress such as urbanization and agricultural intensification.

The natural vegetation universally found in the locality of the town include wooded grassland and thorny bushes, herbs and grasses, despite the density of existing cover of vegetation is very low and limited. Some scattered remnants of acacia and shrubs are commonly available in the surrounding of the town.

2.7 Geological Aspect

It is crystal clear that Mettu town lies in seismic zone of geologically active and stable areas of the central East West regions and Zones. In this locale, tremors that can come suddenly, uproot trees, turn building and houses into rubbles and make people homeless devoid of distinction within a blink of an eye is expected to happen.

3.1. Demographic Characteristics of the Population

The 2007 national census reported a total population for Mettu of 28,782 of whom 14,400 were men and 14,382were women. The majority of the inhabitants practiced Ethiopian Orthodox Christianity, Muslims, with 47.55% of the population reporting they observed this belief, while 26% of the population said they were Muslims in Ethiopia Muslim Orthodox and 26% were protestant.

3.1 Population Size of the town

To start with, population is the total number of men, women, boys and girls, of different ages, living in a defined location at a particular point in time. The size of population of any place is naturally affected by birth rates, death rates, migrations and emigrations.

Mettu town which is getting larger every year experiences rapid surge of population due to high arrival of migrants from the countryside that put pressure on resources, such as water, energy and transportation and so forth provisions.

Natural population growth and rural-urban migration trigger urban population growth from the outset of its establishment. Particularly, rural-urban influxes which are irreversible and unavoidable process in the country widely remained the primary source of population growth in the town which is an ideal place to live, work, and enjoy life.

The number of rural migrants who leave the countryside in search of job and better life is increasing from time to time in the town due to an enhanced socio-economic situation of the town where many people live and work together in close proximity on small area of land. The size of population has showed dramatic change in Mettu town that supports many residents toiling and moiling to transform their life. By a simple calculation, the overall population density of the town is 3,878 per square kilometer. The urban Genda/kebele with the biggest population is Abba mole Sor, whereas, the urban Genda/kebele with the least population is Tabo

Demographically, Mettu town is the 1^{frist} most populous town in terms of population size from Illuabor zone district towns before get the legal personality to Oromia.

3.2. Age Composition

The type of population of the town divided into age segment of young, adult and old age. Mettu's population pyramid shows that the majority of its population falls under the age of fifteen. According to the 2007 population and housing census, the population who age ranges between 15-65 years that are called adult and economically active population and they constituted 69 % of the town residents. The type of populations whose age above 65 years are called old age and constitute 3 % of the total population of the town due to short life expectancy, despite the longevity of town's population is increasing due to change in dietary pattern and health care system.

The dependent group of age 0-14 and above 65 by 2023 projected 40.08 and 4.0431 % respectively. Fair information about age composition can be obtained from the table 3 that is provided below. Table 3; - age composition of population in Mettu town.

3.3 Sex Ratio

The surveys and censuses are sources of demographic information and benchmarks in the town. Mettu has twisted sex ratio. The majority of the residents of the town are women as experiences show and the existing data portrays. The females move to urban areas at a higher rate than men do to engage in job opportunities like domestic worker, house cleaner and waiters which are available for them in urban setting. By 2022, the size of male and female population in the town was the total projected to 264,358 and 265,525 respectively.

3.4 Population Growth Rate

Unlike rural areas, there are a concentration capital goods and better job opportunities that fuel the rural urban migration. As a result, many people are coming in tidal waves from rural areas to urban centers to benefit from the concentration of economic and social necessities in the urban settings in various ways.

From its inception and throughout its history, Mettu which is a destination of many migrants is a land of big opportunities for many people moving from subsistence agricultural areas and an idle place for commercial, industrial, financial, and flourishing lucrative business activities than other towns surrounding it. The exodus of migrants coming from various states and looking for better life and heading to Adama continued unabated and rises dramatically.

As we all know, the movements of people heading towards Mettu by choice from different directions in longer periods have made Mettu one of the cities exhibiting the fastest-pace of population growth, despite exponential growth of the population in the town has placed pressure on the provision of basic services. The town's urban population with annual growth rate that exceed of the national growth rate estimated at 5.4% per year.

3.5. Population Dependency Ratio

Dependency ratio is a measure of the degree of burden created by unproductive population over productive population. The segment of the population below 15 years age and above 65 years are considered as dependent population, whereas the population whose age fall between 15-64 years are labeled as productive population.

The town's population pyramid reveals the fact that people aged sixty four and above comprises 4% of the total population and many of them are without secured means of income in their later stage of their lives. Fair information about population size can be obtained from the table 6 that is provided below.

3. 6. Fertility Rate

In many communities' psyche, children are viewed as useful assets and wives are regarded as a means of reproduction. Women are needed for housewifely, breeding purposes and handling domestic chores that made their life cumbersome and more difficult in the past.

Ethiopian culture encourages having many children as social prestige and social security in their old age to expand their families and bears many offspring. Even if it is difficult to calculate and state the exact fertility rate in the town due to data limitations, there is a trend of declining of fertility rates in the town.

3.7 Ethnic Composition

There are many ethnic groups in Mettu town such as Tigre, Amhara, Gurage, Silxe, Walayta, Sidama, Kambata, Kafa, Mashaa Nyuer, Anyuaak and so on, without any divisions, they have achieved the

tradition of brotherhood, unity and love and are living their lives in a peaceful, tolerance, and stable manner. In addition, the town has no security problems and has been recognized as the Ambassador of Peace in the country.

1.8. POPULATION OF METTU

The town of Mettu used to have three urban villages and a population of over 60,000. Nowadays, due to the expansion of the town, there are rural villages added to the town. The town is a commercial and investment center and many people are coming to our town from various places to make their living as residents of the town, has caused an increase.

Accordingly, the administration of the town has increased from 3 to 6 villages and according to various data, the population of the town is estimated to be 130,027 of which 64,261 males and 65,766 females.

3.8 Religion Composition

There is a sense of tolerance, unity and love among the ethnic groups in Mettu town as well as followers of various religions such as Orthodox, Muslim, Protestant, and Wakefata, but they are conducting their religion in a sense of tolerance and respect without any security problems.

Accordingly, the number of religious institutions in our town:

- 1. Orthodox churches=15 (Fifteen),
- 2. Mosques=21 (Twenty one).
- 3. Protestant churches=46 (Forty-Six) and
- 4. Other 5 Religious Institutions in the town.

There are a total of 87 (Eighty seven) religious institutions in the town. In addition, the above mentioned religious institutions have 41 cemeteries of which 38 have site plans

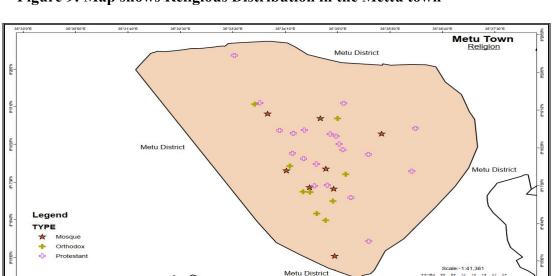


Figure 9: Map shows Religious Distribution in the Mettu town

3.9 Vital Statistics Registrations

Vital statistics is one of the major sources of demographic data at a specified time. Vital registration is also crucial for admission into schools, inheritance or insurance claimer for arranging the transfer of property, a proof age to qualify for social security benefits or options, application for license to operate motor vehicles, the right to marry without parental consent, exercising voting rights, among others.

For this to happen, the town administration has the duty to ensure the preparation of vital statistics that includes the most basic human events such as birth, death, marriage and divorce from vital registration recorded as they occur.

Vital statistics are gathered from birth and death certificates, marriage licenses, divorce records and other official records to mitigate sham marriages and other criminal acts. Figures and facts about vital statistics registrations in Mettu town can be obtained from the subsequent table provided below.

3.11. Mettu Initiative project

As its name indicate, a smart town is defined as a town that engages its citizens and connects its infrastructure electronically to enhance its live-ability, workability and sustainability and improve efficiency of administration and service delivery through installing various easy-to-use software applications.

Smart town infrastructure with network connectivity are manipulated in order to maintain smart interactions needed for most government agencies, schools and hospitals and other users, residents and visitors via smart technologies such as ICT, internet of things, a variety of sensor, CCTV camera and surveillance services, geospatial technology and artificial intelligence.

Mettu initiative was introduced in 2022 in collaboration with MEU, Ethio-telecom, INSA ad AI by Mettu town administration with a view to keep pace with the exponential technological transformation taking place, make the town smarter and safer, simplify works through official software applications and provide prompt serves in a cost effective and inclusive manner,

In this regard, installation of LAN network, scanning documents, Land Information Management System, National Cadaster Real Property Registration System, Queue Management System and Document Management System introduction in land administration office, Integrated Budget Expenditure system and Property Management system debuted in finance office were made in order to digitalize governance, peace and security operations, tax payment system, traffic mobility and control system and healthcare system in the town. Furthermore, the required human resources, logistics, network or connectivity, local area network established, indoor and outdoor surveillance camera TV, outdoor CCTV Camera, biometric attendance machine, situation room, data center, among others put in place in Mettu town.

In this regard, some organizations such as Ethiopian electric utility branch office and water and sewerage services agency instigated to use E-payment and Mettu Municipality unveiled biometric attendance system, identification management system, and urban housing data management system and surveillance camera in the town grappling with countless problems.

4. Socio-Economic Condition of the Town

4.1 The Land Use Pattern of Mettu Town

As its name suggests, land is an excludable element in any development activities and a precious asset for developmental purposes. More importantly, urban land is needed for the establishment of industry, socioeconomic infrastructure, housing, and communication and road networks, among others.

Urban land which is the property of the public and government in Ethiopia in general and in Mettu Town in particular and a buoyant source of income for the town been transferred from the municipality to individuals for various purposes on lease agreement, after the passage of new urban land lease proclamation.

In order to foster controlled direction and pattern of urban development, make human inhabitations successful and produce orderly pattern of urban development master plans allocate urban lands for different land use types in Ethiopia as elsewhere in the modern world. The town has its own a new redraw broad based master plan that prepared during the establishment of the town and revised several times.

Like cities somewhere else in the world, the area of the town currently classified by the 9th strategic plan prepared in 2018 into different urban functions such as administrative areas, residential areas, commercial areas, storage, playgrounds, infrastructure, market, religious, cemetery, recreation areas, mixed use, social services, manufacturing, and other types of development purposes.

Its current strategic plan encompasses well examined urban planning, water supply and sanitation, waste management, urban forest and energy issues for better town development and beautifications of the town. According to the 9th strategic plan of the town which was revised in 2018, the total land area of the town is 31,185.05 hectares. With regard to urban land use, residential areas dominate much of the town's area. The subsequent table displays the land earmarked for various land use according to national urban green infrastructure standard (NUGIS) of strategic plan of 2018 and the preceding structural plan of 2004.

Housing conditions

Shelter is one of those necessities for the survival of human beings on earth in addition to food and clothing. Life without housing is grim and life cannot be realized devoid of affordable housings. More specifically, housing is a crucial element of urban economy and is one of the basic needs of any humanity of all income brackets invariably.

Housing provision is the subject of the government that needs government's political devotion, incentives and interventions to bridge the chasm between haves and have-nots and address the current housing deficit in the country.

In the context of Mettu rapid population growth and massive rural exodus in search of a job and decent life have exacerbated the scar town of conventional housings provision and accelerated the process of hotchpotch squatter settlement formations deprived of basic services and led to a rise in needs for housing and shelter in the town coupled with a continuous construction boom and ever-increasing population growth rate devoid of showing no sign of abating.

The acute shortage of affordable housing is remained pressing and unresolved acute problem in the town. Albeit there was a trend of more persistent housing constructions and residential districts dominate much of the town's area, there is a huge imbalance between the demand for and supplies of housing units in the town.

Some factors that have aggravated housing problems in Mettu town are poor land delivery system, absence of housing loan and culture of saving, shortage of construction material, price escalation of building materials, financial constraints, ever growing inflow of migrants, persistent housing deficits, hike of cost of living, insufficient housing supplies, limited formal land acquisitions, unbalanced rental housing demands and supply, inefficient treatments of housing cooperatives, rigid housing standards and poor living conditions.

Like other major cities in the country, there are two forms of housing ownership in the town. They are public dwellings and private ownership (owner-occupier). Public housings are those houses controlled, ruled and managed by the town government in the town to provide rental housings to the needy of the town at reasonable price. Many town residents are living either in their home or live as tenants in substandard public housings.

Others are still forced to reside in informal housing built on the town's all margins with poor basic public services, drinking water, urban transportations, electric town, sewer system and sometimes life threatening living conditions in which decent standard of living and satisfactory family life is impossible and uncomfortable. Fair information about condominium houses transferred to the beneficiaries by Mettu town administration can be gained from the subsequent table.

Mettu town is the major business corridor where business men dispatch different goods and services efficiently and make huge transactions of industrial goods and agricultural outputs is an important commercial center in the country.

Being there is high cash flow on the daily basis in the town more than other towns in the region, it is a town where most banking, import-export trade, whole selling, financial institutions, commercial buildings, notable malls, light industries are concentrated.

Since its infancy, the lives and livelihoods of the majorities of residents are anchored on trade-related activities directly and indirectly for staying alive, accruing wealth accumulation, transforming them into

high-income bracket of the society in the town, making their bread buttered well, personal growth and changing their life portfolio in many dimensions through engaging in profit-seeking services.

Today, many business premises and persons set feet in Mettu to grasp market opportunities in the town, increase returns on investment, fully reap fat profit from their business firms, earn better life in the town, benefit from the flourishing trade, prosper and transform their mundane lives and lead decent life. Tourism

The infrastructure in the town is more promising from time to time. Accordingly, the existence of a standard asphalt road built by the Federal Government from Finfinne City through Mattu town to Gambella and Masha is crucial for the economic and social development of our town. In addition, 8.7km of gravel road, internal road, cobbled road and asphalt bypass are being constructed by the State Government and the town administration plays a major role. In general, there are 42.16km of asphalt roads, 136.43km of gravel roads, and 18.73km of cobbled roads and 93.42km of wipe roads and the road coverage of our town is reached 76.58%.

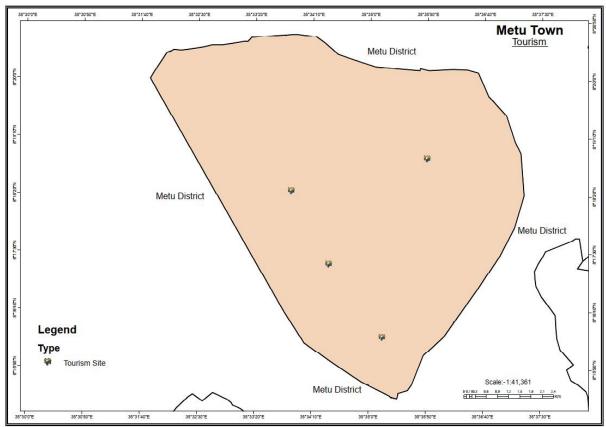

3.4.3.1. Major Local Cash Crops

Urban Agriculture: Currently, urban areas are severely affected by price hikes and high cost of living due to unsystematic rural-urban migration, lack of adequate employment opportunities, underutilized potential of urban agriculture; lack of modern market and natural and man-made hazards in the country.

In order to improve this situation in urban areas, create job opportunities and ensure food security, urban agriculture which provides food and shelter to the urban poor is integrated in to the urban economic and ecological system in urban precincts.

Urban agriculture is also designed to provide balanced diet, fresh milk, vegetables and fruit for urban dwellers, reverse the loss of environmental resources, ensure environmental sustainability, create self-sustaining human development activities and both formal and informal employment opportunities for low-income residents and address the urban crisis in food and nutrition security, the deterioration of urban natural resources in urban and pre-urban areas, or a possible response through agriculture.

Urban agriculture which has an important role to enhance urban food marketing and food security benefits to urban populations includes those areas to be used for farming and animal rearing such as flower garden, horticulture, field cropping, livestock fattening, livestock rearing, and other similar activities in urban areas for the provision with food and other non-wood forest products.

The strategic plan of the town in the pipe line allocated 30% of the total master plan catchment of the town for urban greenery based on topographical settings of areas reserved for urban agricultures that

encompasses urban agriculture to be practiced in pre- urban precinct of the town to alleviate poverty and provide a vital interface between national policies in urban management and local actions.

In particular, urban agriculture is practiced both on irrigated land along the Awash River and rain-fed agriculture in the locale of the town for the production of perennial and non-perennial crops, growing of cereals, leguminous crops/pulses and oil seeds based on agro-ecology and promotion of diversified food production of smallholder farmers depend on monotonous staple diets.

The produces are different types of vegetables (cabbage, carrot, tomato, potato, green pepper, garlic, lettuce and onions,) and fruits (papaya, banana, orange, mangoes and avocado) predicted to thrive for its thrice benefits of protecting the environment, restoring degraded land and ensuring food security in all available open spaces, small scale irrigation and residential corners using composts derived from dry organic wastes in the town, drip irrigation and traditional and modern irrigation schemes on a miniature scale, despite the production failed to cope with demand.

As there is a huge surge in demands for high quality livestock productions such as beef, honey, mutton, butter, pork, hide and skin, cheeses, eggs and milk are growing in the town with rapid growth of population, significant number of the residents are engaged in beekeeping, animal fattening, dairy and poultry farms to eke out a living from agricultural activities.

Urban agricultural activities are essential for a decline in acute and chronic malnutrition, the prevalence of anemia, stunting and underweight, achieving a good balanced diet that contains protein, carbohydrate, vitamin, lipids and minerals, improving protein intakes, income diversification and acute food insecurity reduction via the distributing and application of fertilizer, effective technologies, pesticide including fungicides, herbicides and insecticides and improved seed varieties.

According to the data obtained from Mettu town Agriculture cluster office (2013 and 2014), out of the 18 administrative" kebeles" of Mettu town four of them are pree -town/urban/"kebeles" with 9,884 farmers households among which 6,494 are male and 3,390are female. As one can easily understand from the table below, out of these farming households 9,541 (6,314 male, and 3,227 female) received agricultural extension services:

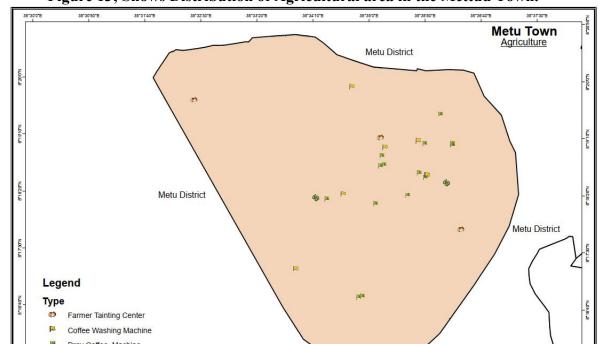

3.4.4. Development activities

It is worth mentioning that the growth and development of any town is contingent upon the existence of transportation, telecom, road, water and electric town networks which are desirable for all activities in the town. The National Urban Green Infrastructure standard (NUGIS) was overhauled in 2014 and stipulated that 30 percent of the land should be allocated for roads and infrastructure, 30 percent for green areas and shared public use and 40 percent for building construction to build economically, socially and environmentally sustainable cities.www.ena.et/en/

Adequate road infrastructure which is one of the development gears of the town and pure public goods entails massive injections of capital. With this belief, significant share of urban land and colossal capital investment are dedicated to road infrastructure network development in urban areas to stick together

public transport system, increase traffic flow in the town, create pedestrian friendly streets and accelerate the development of the town.

The town administration which is the engine of town development was bequeathed the town plagued by a huge backlog of road construction and maintenance work, bumpy and dusty roads unmaintained alley and bumpy roads and crumbled infrastructure in the state of bad condition as the regime was turned blind eyes to the development of these facilities in town due to the protracted civil war and economic downturn.

Based on urban development policy and strategy, after the demise of the past regime, road development which increases property value where they are has got great attention from the town government which is the major investor in road infrastructure.

This move was made to build the town upon solid foundations, guarantee access to basic infrastructure that the residents of the town cannot live without their provisions, maximize equity and social welfare, minimize social costs, address age long public quest, meet diverse needs of citizens, among others.

To recap, the existence of some formidable challenges in road infrastructural development entail town administration' relentless efforts to reduce public dissatisfaction, effectively manage road assets in the town, carry out the project activities in an orderly and efficient manner, enhance contract management, quality assurance and evaluation and monitoring of road development that consumes hefty sums of capital from the coffer of the town administration and other stakeholders every year. 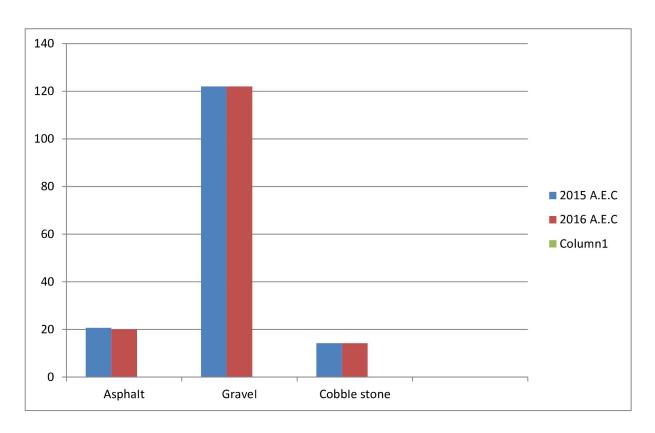


Figure 17: The graph of Road type and coverage in the town, 2017 E.C.

Water Supply Service

There is no coordination of drinking water services in Mattu town before and the community of the town has been complaining about it but now the government has paid great attention to this community complaint and the community of the town is getting drinking water services it is known to exist. Accordingly, although there was no well water in the past, there are 10 wells serving the community at present. In addition, there are 86 wells in the number of springs/rivers which were 5 before, are serving the community of the town. On the other hand, the existing pipeline/well water is currently serving the community of the town with 212.84/80 km/no. Overall, the coverage of existing clean water in Mattu town is over 90%. Transport Condition

When Mettu town underwent reforms, the road from Finfinne through the town to Gambella Region and South West regions was an old asphalt road and there was no internal road, cobbled road, and road leading to the institutions of higher learning institution to Mettu University. Major hotels and entertainment venues were not present. But now the Main asphalt road from Finfinne town to Gambella Region and the South Western Region of the country is asphalt with over 10 km of asphalt internal roads, over 14 km of cobbled roads. There are 4 star hotels being built in the town and the zone, which is playing a major role in the economic and social development of the town. Currently, the town has 1 (One) Bus Station and 9 (Nine) Bajaj Departure and Arrival Destinations. There are more than 60 public transport vehicles serving the community of the town. This proves that our town is achieving rapid growth in terms of transportation services.

Utility Services in the town

It is conspicuous that the economic growth and development of any country is contingent upon the infrastructure includes both physical and social infrastructure development that play pivotal role in bringing national resources into full productive use, transforming the nation's economy and further underpins the country's economic development in various ways. Furthermore, infrastructure is a vehicle for accelerating the development of any country.

Based on this conviction, injections of substantial amount of money into the economy and the existence of transportation, telecom, road, water and electric town networks which are desirable for all activities in the town and means to facilitate transportation of goods and people. In Mettu town context, the provision and improvement of access to infrastructure like road, ridge, market facilities, and clean water supply and electrification services are widely carried out by the town government and federal government of Ethiopia in the town by taking into account the reality of the country.

As the residents of the town need adequate infrastructure and services to lead decent life, Mettu town administration has demonstrated unwavering commitment to invest in physical and social infrastructures and expand utility services which serve as blood arteries and veins of the town in the town accompanied by fast infrastructural development trajectory in the last two decades in unprecedented manner.

The ultimate ambition of expanding physical infrastructures to advance economic performance of the town, improve the connectivity and urban development, realize its vision of becoming a vibrant town in the country, make the town a popular destination of investment and bring tangible change in the lives and livelihoods of the residents. For convenience, the subsequent sections try to throw a perfect light on the expansion of the utility services in the town.

Telecommunication Service

Mattu town community was previously served by few communications; such as Mettu branch Radio, TVO and only a few telephone services. Due to the technological development, the community of the town now has access to communication services such as postal services, social media services, telephone and mobile phone services, telegram, twitter, Mettu University FM, OBN and etc. The town community is highly and fully benefiting from it.

Postal Services

Postal service which includes the distribution of letters, parcels and money is one of the oldest modes of communications that involves the transmissions of messages from one place to another place through different media of communication. Better economic and social developments in the town contributed for better postal services delivery system in Mettu town. Postal service was established in 1936 in the town. Since then, the Mettu postal office gives quite plenty world standard services to the community in the town and its surrounding. Industries: The expansion of industry which involves in the transformation of raw materials obtained from agriculture, mining, forestry and fishery into finished and semi-finished goods is enormously imperative to economic transformation from heavily reliance on agriculture to industry/manufacturing or service sector in Ethiopia where the exporting of non-processed products to the global market badly affected the economy of the country for years.

Dating back to 1950s, Mettu a town is one of the cities where of industrial establishments those largely dependent on domestic resources found in concentration relatively in the country. In this regard, the existing industrial establishments in the town are light industries including textile industries, food processing industries, printing industries, electronic industries, wood (lumber) industries, paper and pulp industries, chemical and building materials that can accommodate many employees and generate many employments in the town and producing mostly consumers goods.

By taking into account the untapped potentials of the town, the industrial parks with the required infrastructure such as access to electric town, water and telecom service to avoid service disruptions

are built in Mettu where sufficient road network, economic corridor, road accessibility, labor force, among others are available.

The essence of the establishment of industrial parks that bring trickle-down effect to the inhabitants of the town in terms of job creation and other economic opportunities was to create jobs the town needs, bring technological advancement, increase the quality and quantity of export items, reduce debt burden, reduce unemployment and poverty, promote economic growth and generate export revenue. Investment Opportunities: As the government alone cannot provide jobs to all population of the country and basic and capital goods with various skills by traditional approaches, the involvement of private sector that supports the country's economy through creating more job opportunities and additional incomes for citizens and bolstering Inland Revenue is tremendously essential.

After the fall of the defunct Dergue regime at the barrel of the gun in 1991, the country was forced to respond to the demands of the new global realities, adjust its politics and economics to the new global realities and change ideological orientation. In the first place, the government was repealed the policies and strategies pursued by the preceding regime and a free market economy economic system was initiated. Subsequently, new investment policy which has a positive spillover effects on the overall development of the country was unveiled by the government.

Good policies that enable investors to engage in various investment activities was created by the government to make the private sector backbone of the economy, promote private involvement in a wide range of investment areas, bring economic development and prosperity for the Ethiopia people,

attract both domestic and foreign origin investors, create import substitution, draw huge foreign currency, expedite socioeconomic progress and spur private sector.

Mettu town which has a wider business opportunity and geographical location

Expansion of Infrastructure Development in the town

The infrastructure in the town is more promising from time to time. Accordingly, the existence of a standard asphalt road built by the Federal Government from Finfinne town through Mettu town to Gambella and Masha is crucial for the economic and social development of our town. In addition, 8.7km of gravel road, internal road, cobbled road and asphalt bypass are being constructed by the State Government and the town administration plays a major role. In general, there are 42.16km of asphalt roads, 136.43km of gravel roads, and 18.73km of cobbled roads and 93.42km of wipe roads and the road coverage of our town is reached 76.58%.

Airport

The airport which is crucial for the economic development of our town will play an important role in making our town an investment center in the future is being constructed with a large budget by the Federal government.

Mettu is surrounded by the Madee and Sor Rivers. These river sites are suitable places for future recreation, urban agriculture center and tourist attraction which will not only promote the town at the national level but also create job opportunities for the unemployed and also play a major role in increasing the town's income.

In addition, Mettu town is the center of the zone and its proximity to the famous tourist attractions of the zone such as Sor waterfall, Ilike waterfall, Gabba Forest, and Sambe mountain represents the economic, social and tourism development of the town with no competition.

Mettu Town has a favorable Climate: Our town gains rain throughout a year and is ever green, conducive to live, and is suitable for summer and winter agriculture; that makes it is crucial for economic growth and investment

Micro and Small Enterprises

It is an obvious fact that the imbalance between population growth rate and economic progress continued unabated in the country that failed to generate jobs enough jobs for millions of young people come out of university every year put many compatriots under social malaise.

More importantly, it is difficult to exercise democracy amidst poverty and unemployment entrenched amongst the youth which forms the biggest slice of the population size. This high rate of unemployment cannot easily be resolved by a single hand of the government.

By taking into account the national context of the country designing viable solution to unemployment which is the main reason for many people to engage in crime and force women to engage in prostitution is extremely momentous to reduce poverty and unemployment through inclusive economic growth, women empowerment and employment creation and wealth generation.

The suitable solution to facilitate job creation for a large youthful population segment with innovative minds in Ethiopia which is endowed with a large number of working age population and lacks industry and employment that accommodate thousands of enthusiastic graduate who join the work age every year and wish to get jobs as soon as they graduate and do not like sitting idly is establishing micro and small enterprises (MSEs) which is one of the nine pillars of urban development and housing policy.

With the intention of increasing the role of MSEs in national development, the government of Ethiopia prepared the first National Micro and Small Enterprises Strategy in 1997 which affects the lives and livelihoods of the poorer segments of the communities in order to reduce youth unemployment and poverty that bring about psychological trauma and dissatisfaction among the youths, deter illegal migration costing the lives of fellow countrymen, enable jobless citizens to commence their business, generate income and improve the lives and livelihoods of themselves and their families.

In Mettu town context, it is difficult to quantify the number of unemployed residents living in a very dire condition in urban precincts, despite the number of unemployed youth is progressively more growing due to poor employment creation and the unavoidable and irreversible rural-urban migration.

As a microcosm of the national situation, the town administration which is mandated to well-defined roles and responsibilities in poverty alleviation activities in urban precinct has established job creation and skill development office in order to catalyze the job creation initiative, expand income generating activities in urban agriculture, tourism, manufacturing, among others, organize trade fair that has great values for

producers, retailers and manufacturers, create market contacts at home and abroad, enable jobless' access to plots, loan, technology, market, training, among others based on national policy.

More or less, Mettu town many job seekers are secured jobs. The direct beneficiaries from micro and small enterprises are youth, women and the low income group of the society who have been involved in different associations to engage in textile and garment, leather and leather products, construction inputs, traditional clothing, food items, mining, metal and wood products. Saving and Credit Associations

In Mettu town, many saving and credit associations that contribute to the country's economic development are established in the town by individually having similar interest and living in proximity to provide services and engage in the production and service delivery activities for their members.

These saving and credit associations are expanding steadily in the town across economic divides with a view to allow mutual support, encourage saving, bring together their knowledge labor and resource voluntarily, foster saving culture between members and collectively overcome economic and social problems which members cannot individually achieve.

In Mettu town there were 107 primary Savings and Credit Cooperatives (SACCOs) till 2014 A.E.C. The total numbers of members were 18,190 of which 9024 & 9357 are male and female respectively. With regard to their financial status, they have a total capital of 288, 224, 882 Birr. Out of 107 primary cooperatives, 56 primary cooperatives organized under one Saving & Credit cooperative Union to develop their financial strength and foster capital growth.

Moreover, Saving & Credit cooperative Union has 56 member primary cooperatives which have 14,994 members (7,696 males & 7,298 females) and a total capital of 329,259,104.65 Birr

Urban Productive Safety Net Program

Urbanization brings with it a number of positive and negative consequences affecting the lives of the constituents of any urban milieu. Traffic chaos, pollution, incivility, terrible and horrible crimes and odd practices like drugs, unemployment and the problem of food insecurity those always upset the society are some of the negative sides of urbanization in urban settings in the age of globalization.

Ministry of Urban Development and Housing has unveiled pro-poor policies and growth and poverty reduction the subsequent an Urban Food Security Strategy in 2015 in order to meet the varied needs of the poor and vulnerable community, tackle the urban food insecurity and poverty and identify the poor in the villages via the UPSNP Principles (goal oriented, fair and transparent, timely, predictable and appropriate transfers, integration with local sustainable development plans: gender equity) as an integral component of Urban Food Security Strategy.

The UPSNP which is a five-year phase of the government program targeted 11 major cities with the highest rates of poverty. Mettu is one of the selected cities among 11 major cities selected for urban productive safety-net program in Oromia regional state by the time. The UPSNP has been under implementation in Mettu town since April 1, 2009 A.E.C.

The main components of the projects are public work implementation, Capa town building & institutional strengthening activities, permanent direct support of urban destitute and livelihood services. The strategy aims to tackle poverty, implement poverty reduction strategies, avoid dependency syndrome, promote shared prosperity and reduce extreme poverty and vulnerability among the urban poor living below the poverty line inner town of 14 Kebeles in the project years.

Mettu town got the services of the Planning House in 1987 but so far it is showing improvements in all aspects; but it has not received the necessary level of promotion. The town is self-sufficient in its own revenue and the progress in providing development of infrastructure to the community is encouraging. On the other hand, the economy of the town is based on trade and agriculture. The town's income is increasing from time to time, which proves that the socio-economic income of the people of the town is improving.

Since Mettu town got the services of the Planning House in 1987, its regular income has been increasing from time to time and the development of infrastructure and its social development also increasing. Accordingly, the previously collected Revenue from the Planning House was 21,842,047.66 ETB; which is now 42,900,662.56. In addition, the Ordinary Revenue collected in 2011 was 48,635,123 birr which is now 118,235,335. This indicates that the growth of the town is increasing rapidly.

Based on these convictions, various consumer associations are set up in the town to keep prices fair, supply food and non-food items at a competitive price, avoid unreasonable upswing of price fixing, save the consuming majority from unfair and unnecessary costs as quickly as possible and uplift the socioeconomic condition of their members and local communities. Micro-Finance Institutes

Banks, which are targeting the more affluent section of the society with equity contributions and the rigorous collateral requirements of convectional banks and submitting bankable applications to secure loan from banks, before lending any amount of loan are always reluctant to provide loans to causal workers, start-up businesses and self-employed segments of the society because of unstable income, lack loan guarantees and collateral such as land, buildings, and modern business plan to draw loans from commercial banks and other financial institutions.

These formidable challenges prevent the youth and other borrowers from putting their business ideas into practices. Knowing these formidable challenges of lack of access to microfinance credit loan programs in the region, eight micro finance institutes which support citizens participated in small business are opened their branches in Mettu town.

Their establishment of the town is critical to fill the gap in loan acquisition in the urban and hinterlands, support low-income groups who cannot borrow from domestic capital markets, prevent borrowers from dependency on informal lending sources or usury, among others. Trees planted in green spaces in urban areas absorb more co_2 that emitted by cars and animals into the atmosphere than any living creature on earth in their trunks, roots, leave and branches in urban areas and release oxygen which is a

priceless commodity for our existence when they use energy from sunlight to make glucose from carbon die oxide and hydrogen and sequester carbon.

The study of Bayram Cemil Bilgiliand Ercan (2012) cited that 'urban green spaces refer to land uses covered with natural or man-made vegetation in the town.' Equally, Maria-Laura Tîrlă, Gabriela Manea, Juliana Vijulie, Elena Mateiand Octavian Cocoş (2014) were noted unanimously that the green town means a way to increase the sustainability of urbanized areas.

The 1995 national constitution (article 43 and 44) which is the super territorial law in the country stipulated the 'right to a clean and healthy environment' in Ethiopia. Urban greenery has become the new attention grabber and a priority in the country. The legally binding current strategic plan of the town follows 30%, 30% and 40% out of the entire catchment of the urban land for infrastructure, greenery and built-up area respectively to bring a paradigm shift on land use in urban setting.

According to the NUGIS, 30% of urban land under the dominion of the town administration is budgeted for the environmental use category which includes River Bank Green/Buffer, Road side green, Nursery, Mountain green frame, Parks, Botanical garden, Zoo by the strategic plan of the town under the pipeline to meet the new laws and regulations of urban planning of the country.

The generic rationale was to ameliorate some of the negative consequences of climate change and UGHE in urban milieu, provide sufficient, reachable and functional green spaces deserve to be increased in an environmentally healthy way and improve the wellbeing of the residents at this specific time.

Regarding park, Diaspora Park, Dambala Botanical and recreational park, Migra Park, Caffee Park, Boku Urban Zoo & Botanic Garden and the likes which can be used for recreational purposes exist in different places of the town.

Likewise, the essence giving great emphasis to urban greenery which is coined as 'the lung of the town' in the town by taking into account the current national and global scenario is to build sumptuous and preferable urban areas for healthy life, curb the imminent ill sides of the growing car ownership and climate change repercussions, absorb looming pollutants, carbon die oxide and waste heat from energy consumption and create safe, resilient, healthy and sustainable country for citizens in accordance to the climate resilient environment and green economy development strategy. In addition, 8.7km of gravel road, internal road, cobbled road and asphalt bypass are being constructed by the State Government and the town administration plays a major role. In general, there are 42.16km of asphalt roads, 136.43km of gravel roads, and 18.73km of cobbled roads and 93.42km of wipe roads and the road coverage of our town is reached 76.58%.

The Town of Mettu Has an Airport: The airport which is crucial for the economic development of our town will play an important role in making our town an investment center in the future is being constructed with a large budget by the Federal government.

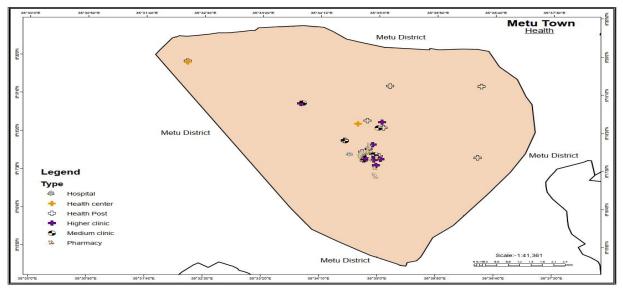

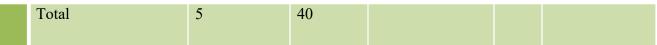

One of the public goods and services supplied by the government to the citizens in many countries of the world by taking local context into consideration is the provision of health and education services. With this belief, Emperor

Hailesillase with progressive idea was established more and more schools and health system with a lean budget in the country where only religious educations offered in Geeze and Arabic languages in celestial schools and Quran schools in the country to inculcate religious denominations and dogma in the heart and minds of the worshippers of the religions, since the country was liberated from the Italian occupation in 1941. The widespread school development in major towns and some rural areas were made by the time to extricate the country from the shackles of backwardness and under development, think out of the box, shape citizens' thinking pattern, produce the required human resources in divers areas of study for the development of the country, enjoy the fruit of civilization, impart knowledge and skills to individuals and indoctrinate collective thinking, values and ethos. Since then, unflinching determinations were made by erstwhile successive governments ascended to power in the country and the incumbent to bring up strong citizens in terms of attitude, knowledge and skill, end the vestiges of outmoded and harmful traditional practices, build human capital, and create dynamic, responsible and vibrant generations which are the crucial asset of the country. In context of social service, a glimpse of picture about Mettu town can be obtained from the following explanations that will be made on education and health facilities in the town succinctly.

Education Service

General Education

Since education centers are the places where personalities of youth develop, hefty budget is earmarked annually by the town government to provide free and compulsory education, hire teachers, expand education facilities, reduce student-class and student-teacher ratios, improve libraries and laboratories and renovate dilapidated classrooms those have significant impacts on students learning outcomes, albeit the share of private schools in all level of learning is increasing from time to time.

As the descriptive statistics and figures convey, there is a success story in expanding education in the town. The current patterns of school ownership in Mettu town is diverse those include government, private, mission, religious, special-purpose institutions, and community schools with different uniforms. As a result, Mettu has witnessed unprecedented enrollment growth. The tables and maps provided below disclose some interesting facts about number of schools and students in all level of leanings in the town.

As is indicated in the above table the gross and net enrolments of students of primary schools in the 2014EC were 78,887 and 72,042 in the mentioned academic years. In addition, the gross and net enrolments of students of secondary schools were 31,477 and 23,980 in the academic years.

Education Quality and Efficiency Indicators

A good quality education is required to become economically productive, develop sustainable livelihoods, contribute to peaceful and democratic societies and enhance individual well-being of citizens. On the other hand, efficiency is the relationship between the outputs and inputs of an education system. Pupil to section ratio (PSR) and pupil to teacher ratio (PTR) are some of the indicators efficiency and quality in education. They indicate an average number of pupils per class and give a rough estimation of class size and assess the efficiency of resource utilization. The national standard set for PTR is 50 at primary (1-8) and 40 at secondary level. On the other hand, the national standard set for PSR is 50 at both primary and secondary level. In Mettu town context, the (PSR) and (PTR) situation can be attained from the subsequent table.

Technical Vocational Educational Training

Some years back, there was no job opportunity for the graduates of TVETs from these few vocational schools established in the country which can offer a wide array of career options in many different industries. As a result, past regime was brushed aside the concern for vocational education that undermined innovations and the utilization of modern technology in efficient manner in the country to meet their developmental needs.

In contrast, the beginning of structural change in the economy of the country has favored the change of education and training policy in 1994 that is applicable to the needs of the country to upgrade its human capital skills and technology utilization, improve the education system based on the country's concrete condition and focus on technology and science based hard skill over soft skills recently.

Moreover, the increasing demands for blue-collar workers were forced government to improve its education system, formulate new education policy and revise the old curriculum and educational system preventing creativity from flourishing.

Presently, Ethiopia has placed much attention to vocational training in order to fill the gaps in technology and innovation in the country and meet the demands of the market and industry, actualize technology transfer in various fields, simplify the livelihood of many people, accelerate the economic transformation, take the country to the pinnacle of success and extricate itself from poverty and backwardness and become a prosperous country.

To achieve the aforementioned goals, many TVETs with adequate human and material facilities are established in the town in accordance with the guidelines designed by the government to foster innovations within the country, produce blue-collars alumni with vocational skills, raise labor productivity, curb youth unemployment, meet the demands of the market and industry.

As a result, many students are enrolled in vocational training schools in the town to enable them to equip themselves with the required skill and knowledge and change their life scenarios. Fair information about technical and vocational education training in the town can be obtained from the table provided below.

As a hub of intellectual life and learning, Mettu town is a home to many private universities and college. It is also the birth place for the Rift Valley University College and other colleges. Presently, the town is the domicile of Rift Valley University College, Unity University College, Harambe University College, Sub-Saharan University College, Genius land University College, Royal university college, Oromia college, among others. Fair information about private colleges and universities can be attained from the consequent map.

Mettu Science and Technology University

For any successful economy science and technology which are oxygen for innovation are the basic prerequisite to develop the human skills and administrative structures and are needed to exploit their resource and sustain economic growth efficiently and effectively.

Recognizing this undeniable fact, Nazareth technical college was initially established in the town in 1986 EC (1993) by the assistance the French government to accelerate the pace of technological innovation, upscale the use of innovative technology to transform the life of citizens in Ethiopia.

Initially, it was upgraded to Nazareth College of technical teacher education. Later, it was promoted to the status of Mettu University in 2005 and was renamed by the council of ministers Mettu Science and Technology University in 2011.

Mettu town is fortunate to have this prestigious and reputed in the town that has been chosen as a model university to work as the center of excellence in science and technology in the country.

MEU has created conducive environment for tertiary education seekers in the town and opened various programs in applied and engineering technology which is fundamental for all development and dedicated to offers a wide range of post and undergraduate programs, produce competitive and ethical graduates and innovative knowledge and emerging technology.

4. Problems and Potentialities:

4.1. Problems Concerning:

4.1.1. Economic conditions- Disease like malaria is highly affected the in the townhouse rent, market condition current time. Lack of construction material and shortage of home land in the area that increased number of un employment ratio.

4.1.2. Social Conditions

Social Justice

Crime is the intentional commission of an act usually deemed socially harmful or dangerous and specifically defined, prohibited, and punishable under criminal law in the world of today unanimously. Criminals, on the other hand, are persons who have committed crime. In Mettu town context, the criminal cases lodged, decided and pended cases in the year 2015 and 2016A.E.C presented in this profile with a view to demonstrate the number of crimes committed in the town and the number of perpetrators in the crime in the town.

According to data constellated from the Higher Court of Mettu town, 619 people involved in criminal cases in 2015 A.E.C. These cases were presented to the eligible higher courts of Mettu town. Out of the cases presented to the higher court of the town 592 cases were decided and the remaining 27 cases were pended to 2016 fiscal year.

Similarly in 2016 about 814 criminal Cases were presented to the Court out of whom 773 cases were decided and the remaining 94 cases were pended to the next fiscal year. As learnt from the data collected from Mettu town higher court, more than half of the criminal cases presented to the courts were decided by the judges deployed in the court. 5.2 Social Security

Social security primarily refers to a social insurance that provides social protection, or protection against socially recognized conditions including poverty, old age, disability, unemployment and others. Unemployment is one of the serious challenges in urban area at this critical time. In this regard candid efforts were made in the town to create job opportunities and alleviate poverty in the town.

The data constellated from the office of social and workers affairs office of the town reveals that the total number of economically active population of Mettu town was 349,135 (Male 176,809 and Female 172,326). Regarding their education background, 3.1% of the unemployed and job seekers were illiterate and about 4.84% were diploma holders and above and 44.12% were Grade 9 and above. By 2015 A.E.C, 33,386 (17,493 male and 15,893 female) were unemployed in different government and non-government institutions in the town in the town.
